PC-Doctor Trademark Usage Guidelines

The following guidelines address the correct treatment of PC-Doctor's trademark as it is used in advertising, technical, collateral, and other printed, Web or visual materials.

Permissions to Use PC-Doctor Mark.

A Party may only use the PC-Doctor Mark in conjunction with PC-Doctor product(s) that are validly licensed and under a current PC-Doctor license agreement.

Name Usage.

The company name for PC-Doctor is "PC-Doctor, Inc." This should be reproduced exactly. "PC" is in all capital letters, there is a hard hyphen between "PC" and "Doctor", "Doctor" begins with a capital "D", followed by a comma and a space, followed by "Inc.", which starts with a capital I, and ends in a period. "Inc.", the abbreviated form of Incorporated should be used. After the first occurrence, "PC-Doctor, Inc." can be abbreviated to "PC-Doctor".

"PC-Doctor" or "PC-Doctor, Inc." should never span two lines. To prevent PC from being hyphenated and Doctor falling on the next line, insert a hard hyphen; in Word press [CTRL] [SHIFT] [-]. To prevent "Inc." from falling to the next line insert a hard space between the comma and "Inc."; in Word press [CTRL] [SHIFT] and space.
